#### **REQUESTED ACTION**

To review the following contract authorization.

#### BACKGROUND

Per our Financial Policies, Section VII. Purchasing and Contracting, the Commission must approve contract/award amounts in excess of \$250,000. The following award requires specific authorization from the Commission.

#### SupplyBank.Org - \$900,000

First 5 Alameda County (F5AC) is requesting approval of a sole source FY 2020-21 \$900,000 contract with SupplyBank.Org to purchase and distribute essential community supplies including but not limited to diapers, wipes, adult and child face masks, hand sanitizer, all-purpose cleaners, hand gloves and air purifiers to F5AC identified distribution sites. F5AC recently received funding from Alameda County Social Services to administer federal CARES Act funding to support families and providers affected by COVID-19 and the monies are to be spent by December 30, 2020.

Fiscal Impact: Funding will be received from a new FY 2020-21 contract with Alameda County Social Services Agency and will be added to the FY 2020-21 mid-year budget modification.

#### Action requested: Recommend a FY 2020-21 award amount of \$900,000 with SupplyBank.Org.

#### RECOMMENDATION

That the Executive Committee recommend the above contract authorization be brought to the Commission for approval at their next meeting.

Subject: 2021 Cost of Living Adjustment

#### **REQUESTED ACTION**

That the Executive Committee review and discuss the recommendation for a 2021 Cost of Living Adjustment (COLA) of 3.25%.

#### BACKGROUND

Per the Salary Guidelines approved by the Commission it is the Commission's responsibility to grant a COLA to employees. If awarded, COLAs are granted to all regular employees, both full and part-time, at the beginning of the calendar year. Typically, COLAs are implemented to ensure that employees' wages do not lose real value due to increases in the costs of goods and services.

Competitive salaries are an important recruitment and retention strategy; the ability to consider a COLA is particularly important for retention purposes considering that many of our employees' salaries are capped and, as a relatively small agency, promotional opportunities are limited. If approved, COLA adjustments will be applied to our salary ranges. We would anticipate applying the COLA on the December 28, 2020 pay period and with it reflected in employee paychecks on January 22, 2021.

#### DISCUSSION

#### Alameda County COLAs:

As a partner, we have always looked at Alameda County's COLA practices in an attempt to provide comparable benefits to remain a competitive employer.

SEIU, representing the majority of non-exempt employees at Alameda County, will receive a COLA of <u>3.25%</u> effective 6/27/21.

ACMEA, representing the majority of management and professional level employees at Alameda County, will receive a <u>3.25%</u> COLA on 12/27/20.

## Consumer Price Index:

The Bureau of Labor Statistics has reported a 5.2% increase in food prices and a decrease of 9.7% in energy (largely a decrease in gas prices) for an overall increase of 1.1% over the last 12 months (November 2019 – October 2020).

# **FISCAL IMPACT**

The fiscal impact of granting a 3.25% COLA for the six-month period of the current fiscal year is \$107,063 which was included in the FY 2020-21 Commission approved budget in anticipation of keeping consistent with the County.

#### RECOMMENDATION

That the Executive Committee recommend the Commission grant a 3.25% employee Cost of Living Adjustment (COLA) to take effect for the calendar year of 2021.
